SWO HOSTS WELCOME HOME VIETNAM VETERANS EVENT

SDDVA Secretary Whitlock had the great honor to address over 90 Vietnam Veterans last week at the Sisseton Wahpeton Oyate Welcome Home Celebration and Honoring ceremony.

In his remarks, Secretary Whitlock shared this message. "Vietnam Veterans were a generation of veterans that came home, and even though some Americans turned their back on them – they never turned their back on America. Like generations before them, they took off the uniform, but never stopped serving. They became leaders and public servants, from town halls to Capitol Hill -- lifting their communities, our state, and our nation."

VA PENSION DEBT AND TIMELINESS STANDARDS

The United States Department of Veterans Affairs reports that in 2011 and 2022, challenges in data matching resulted in an inability to reliably verify the self-reported Social Security income for veterans and survivors receiving a VA pension. Upon resuming income verification in June 2022, the VA discovered that over 9,900 beneficiaries had higher incomes than reported, leading to overpayments in some instances over many years. As required by law, the VA established debts for these veterans and survivors and contacted them to recoup overpayments. Upon further review, it was also discovered that an additional 30,000 veterans and survivors might also have pension debts that have yet to be established.

In November 2023, recognizing the hardship such debts may impose on this vulnerable group, the VA halted the collection of all established pension debts and the formation of new debts while exploring all possible relief options.

However, as the VA continues to process other claim types, such as dependency claims or medical expense reports, the VA conducts an income match and may identify additional debts. During the period between Nov. 2023 and now, the VA has determined that more than 12,000 pension beneficiaries (up from the initial estimate of 9,900) had higher incomes than reported. Some of those were initially part of the 30,000 that had not yet been processed. The VA anticipates this number will continue to increase as additional claims are processed. Currently, the VA has more than 27,000 individual claims related to the SSA match to review.

Based on the VA Secretary's December 2023 guidance, the VA has decided to not collect pension debts associated with the June 2022 SSA income verification match and will contact the 12,000-plus affected individuals directly to inform them of the resolution process. Additionally, they are refunding beneficiaries for any payments already made as a result of this income verification match. The VA is also reviewing the causes of the data quality issue to prevent future occurrences.

The VA extends their apologies to the beneficiaries impacted by these pension debt notifications and will assure them that relief efforts are underway. Following is a summary of the recent developments and the current status of this issue.

Recent Developments:

- Effective November 2, 2023, the VA suspended the creation of new debts and the collection of existing debts related to this issue.
- On December 22, 2023, the VA Secretary issued guidance to not collect any debts arising from the June 2022 SSA income match and to refund any collections already made.
- January through early March 2024, the VA worked with the Debt Management Center (DMC) and Veterans Benefits Administration's Office of Financial Management on mechanisms to stop collection of debts for beneficiaries.

PENSION DEBT (CONTINUED)

Current Status:

- VA continues to run this match quarterly since June 2022 to further identify beneficiaries and identify income discrepancies earlier.
- VA will inform the 12,000-plus affected beneficiaries about adjustments to their pension debt balances.
- Beneficiaries will be notified of their updated debt balances and the reduction in debt amounts.
- Beneficiaries who have made payments based on prior notifications will be informed of the refunds.
- VA is developing updated procedural guidance for claims processors related to the additional 27,000 beneficiaries identified in the June 2022 SSA income match. VA anticipates resuming claims processing by May 2024.

Actions for Beneficiaries:

Affected beneficiaries will receive a letter from the DMC. No further action is required if the current debt balance is \$0.00. For those with existing debt balances, the VA is ready to assist in managing these debts. REVIEW OF SOUTH DAKOTA 99TH LEGISLATIVE SESSION

The 2024 Legislative Session is a wrap! There were 550 bills, commemorations, and resolutions introduced this year.

The South Dakota Department of Veterans Affairs introduced two bills this year and monitored 29 pieces of proposed legislation.

Bills introduced that were veteran related focused on education benefits, property tax relief, hunting, long-term care services, residency requirements for admissions to the state veterans home, employment of veterans service officers, establishing a code talker memorial, fee charging for filing of veterans claims, Medal of Honor recognition day, specialty license plates, removal of fees for birth certificates and ID cards for the homeless, and appropriations to fund state government and the respective programs. As always, not all bills that are introduced survive.

Veteran related bills and resolutions that were approved and will become law July 1 are as follows:

Senate Bill 29 expands the State Tuition Assistance benefit for the airman and soldiers of the South Dakota National Guard allowing them to utilize their State Tuition Assistance benefit at an in-state private, nonprofit post-secondary university. This benefit increases the South Dakota National Guard's ability to recruit and retain high-quality Soldiers and Airmen to better serve the citizens of South Dakota in their time of need.

SB 80 appropriates \$2 million to provide grants to select providers for technology improvements for providers of elderly care and to make an appropriation therefor.

SR 701 encourages congress to open an official inquiry into the Medals of Honor given to United States soldiers for their involvement in the Wounded Knee Massacre of 1890.

HB 1007 provides counties and tribes who encounter prolonged VSO vacancies the opportunity to contract with the South Dakota Department of Veterans Affairs to provide those services.

HB 1008 removes the South Dakota residency requirement to be eligible for admission to the State Veterans Home.

HB 1013 adopts the advanced practice registered nurse compact.

HB 1015 adopts the social work licensure compact.

HB 1067 designates March 25 as a state Medal of Honor Recognition Day.

HB 1068 allows disabled veterans to obtain a standard issue county motor vehicle or motorcycle license plate.

HB 1082 changes the eligibility requirements, and the exempt value, of a property tax relief program for disabled veterans and surviving spouses from \$150,000 to \$200,000.

HB 1101 provides a special motor vehicle license plate for recipients of the Legion of Merit award.

HB 1131 waives certain fees for nondriver identification cards for individuals who are homeless.

HB 1231 places restrictions on the ownership of agricultural land.

HCR 6007 encourages the United States Congress to allow veterans to receive long-term care services at facilities that do not otherwise meet the requirements set by the VA.

HCR 6010 acknowledges the need to protect our borders and affirming South Dakota's support of the defense of the southern border.

HC 8012 honors the victims of Agent Orange during the Vietnam War.

None of these bills had an emergency clause on them, so these bills will become law effective July 1. SDDVA will be updating forms, the VSO Manual, and the website with these changes. You can review any of the bills at: https://sdlegislature.gov/Session/Bills/69.

The Legislative Executive Board will meet the end of March to select topics for interim study committees to review this summer.

VETERANS PROVIDED INCORRECT INFORMATION

The United States Department of Veterans Affairs was recently notified and confirmed an error by a contract service provider that nearly 6,000 veterans and/or accredited representatives received letters advising them to submit an incorrect form. Veterans and/or accredited representatives who submitted outdated forms for decision review requests (VA forms 0995 and 0996) were sent letters directing them, inaccurately, to submit form 526EZ.

The VA will ensure all affected veterans are made whole and they receive the benefits they have earned. Claims identified as impacted are being processed with adjusted effective dates and using the date of their original submission as appropriate.

The VBA continues to examine data to identify which cases are resolved satisfactorily and those that remain to be completed. The data breakdown will be provided once it is available.

On March 7, 2024, the VA was first alerted to the error by veterans, veteran service organizations, and VA Regional Office staff members. The VA and the service provider took immediate corrective action to stop inaccurate letters from being sent by deploying system fixes to the automation process.

Additionally, the VA has initiated appropriate contractual actions to hold the service provider accountable for the failure and lack of appropriate configuration management procedures. The VA utilizes the service providers automation capabilities to support receipt of claims and evidence submitted to VBA. To ensure the automation services are operating as designed, a full operational review will be required by the vendor. In parallel, the VA will conduct an independent technical analysis of the service provider's solution and after-action report.


The Power of Choice

The Inspiring Story of Melissa Stockwell, an Army Veteran and Paralympic Athlete Melissa Stockwell served as a Second Lieutenant in the US Army, and was deployed to Baghdad, Iraq in March 2004. Sadly, just three weeks into her deployment, a roadside bomb hit her Humvee causing the loss of her left leg above the knee. After undergoing several surgeries to recover from multiple infections, Melissa was honorably discharged from the Army. As the first female soldier to lose a limb in active combat, she was awarded both The Bronze Star Medal and the Purple Heart.

Despite the tragic incident, Melissa turned to sports for recovery. She made history in April 2008 by becoming the first Iraqi War Veteran to qualify for the Beijing Paralympics. She then shifted her focus to Paratriathlon and went on to become a three-time World Champion. Her talent and hard work led her to win the Paralympic Bronze Medal at the Paralympic Games in Rio de Janeiro on September 11, 2016.
