The South Dakota Department of Veterans Affairs (SDDVA) is now accepting nominations for South Dakota's Fallen Heroes Bridge Dedication program.

In South Dakota, a powerful initiative is underway to name bridges in memory of the men and women from South Dakota who gave their lives in service to our country. This gesture offers us an opportunity for remembrance, reflection, and respect, ensuring that the sacrifices made by these brave individuals are never forgotten.

By naming these bridges in honor of fallen service members, the state not only recognizes their courage but also provides a tangible symbol of our collective gratitude. Each bridge represents more than just a structure of concrete and steel—it stands as a lasting tribute to the sacrifices made for our freedom.

This initiative not only gives us a space to honor the fallen but also encourages us to reflect on our responsibility to uphold the values they fought for.

Every time we cross one of these bridges, we can be reminiscent of the legacy of those who serve, reminding future generations of the cost of freedom.

Nominations, with all supporting documentation, are due by April 1 to the South Dakota Department of Veterans Affairs. The simple, online form is available on the <u>Bridge Dedications page</u> on the SDDVA website. Nominators are encouraged to indicate their preferred state bridge site for their respective hero.

VETERANS GET MORE TIME TO TRANSITION TO NEW ONLINE LOGIN SYSTEM

The U.S. Department of Veterans Affairs announced it will provide veterans additional time to transition to a new online login system that lets them more quickly and securely access information about their VA health care and benefits.

In July, the VA announced a <u>phase out of My HealtheVet and DS Logon sign-in options</u>, in favor of two new options, Login.gov and ID.me, which will help the department offer stronger protections for veterans, families and caregivers.

With today's announcement, the VA is extending the final deadline by which veterans and beneficiaries can log in to VA.gov, VA mobile applications and other VA online services using their My HealtheVet username and password from Jan. 31, 2025, to March 4, 2025. The dead-line to switch from DS Logon to ID.me or Login.gov remains Sept. 30, 2025.

Most VA beneficiaries are already using Login.gov and ID.me to access My HealtheVet and other VA digital services, but the VA will use this additional time to ensure as many veterans and beneficiaries as possible make the switch before the old My HealtheVet username and password system is retired March 4. In addition, the VA is increasing outreach to veterans who have yet to make the switch and will provide in-person assistance at VA Medical Centers across the nation.

VA ANNOUNCES RETURN TO IN-PERSON WORK POLICY

The United States Department of Veterans Affairs announced its return to in-person work policy, which states eligible employees must work full-time at their respective duty stations (agency worksites) unless excused due to a disability, qualifying medical condition or other compelling reason.

The announcement follows President Trump's Jan. 20, <u>presidential memorandum</u> on return to in-person work.

More than 20% of the VA's more than 479,000 employees currently have telework or remote work arrangements. As part of the new policy:

• Political appointees, senior executive service members, SES equivalents, senior level and scientific and professional employees will no longer be eligible for remote work arrangements. By Feb. 24, 2025, their telework agreements will be terminated, except for ad hoc or situational telework.

• Also, by Feb. 24, 2025, remote work and telework arrangements for supervisors with current official duty stations within 50 miles of an agency facility will be terminated, except for ad hoc or situational telework.

• By April 28, 2025, remote work and telework arrangements for non-bargaining unit employees with current official duty stations within 50 miles of an agency facility will be terminated, except for ad hoc or situational telework.

• Remote work and telework arrangements for supervisors and non-bargaining unit employees with current official duty stations outside 50 miles of an agency facility will not be terminated at this time. Further guidance will be forthcoming regarding these arrangements.

• Return to in person work requirements for bargaining unit employees will be announced at a later date.

The VA's policy allows exceptions for arrangements approved for employees as a reasonable accommodation due to a disability or a qualifying medical condition. Exceptions may also be allowed for military spouses with permanent change of station orders.

"This is a commonsense step toward treating all VA employees equally," said Acting VA Secretary Todd Hunter. "Most VA clinical staff don't have the luxury of working remotely, and we believe the performance, collaboration and productivity of the department will improve if all VA employees are held to the same standard."

Dr. Kim Gorgens is a board-certified rehabilitation psychologist and Professor at the University of Denver. She specializes in brain injury research, criminal justice, and vulnerable populations like athletes, inmates, persons who are unhoused, and individuals exposed to violence.
